April 11, 2011 Current FIXED interest rates available from County Corp Development for small businesses looking for capital for fixed asset acquisitions are:

- SBA 504 20 year interest rate is 5.90% - *changes monthly*
- SBA 504 10 year interest rate is 4.89% - *next update in May*
- State of Ohio Regional 166 (<=15 yrs) FIXED interest rate is 2.00%
- CDBG Revolving Loan Fund (Montgomery Co., OH only) is 3.00% for up to 15 years
- Child Day Care Loan (Montgomery Co., OH only) is 3.00% for up to 5 years
